- For awarding degrees to successful Post-Graduate students, the basic requirement for course work, and research work Thesis write-up and other approved conditions were strictly followed.
- 6. The university has adopted HEC plagiarism policy (version 2.0) for Graduate programs.
- Registered Post-Graduate students MPhil/MS are guided & co-guided as per directions of the HEC.
- Similarly, the MPhil/MS minimum and maximum time is followed per HEC-QAA guidelines.
- 9. SBBU-SBA organize National and International conferences, symposiums, and also workshops and seminars on statistical analysis through some software like SPSS and PLS SEM to develop students' technical skills necessary for conducting robust research and analyzing data effectively along with other areas of research.
- 10. SBBU-SBA provides students the access of wide range academic journals and library services. This enables students up-to-date with the latest research in their field and identify potential journals for publication.
- 11. SBBU-SBA University has constructed 02 new hostel blocks for the male and female students and one more academic block with all facilities, classrooms, labs and the extension of Admin block to accommodate newly appointed officers of the university.

 environmental responsibility
- SBBU-SBA should engage students and faculty for community service through offering short courses for schools, colleges' students arranging blood banks, awareness seminars and workshops for community, this initiative will promote higher education awareness and foster long-term academic partnerships.
- QEC must ensure timely student and faculty feedback data, preparing and sharing analysis report
 to all concerned along with Employee Survey, and Alumni Surveys. This data-driven approach
 will enhance program quality and faculty satisfaction
- SBBU-SBA ensure to upload on university website, University Act, Statues, prospectus Quality
 policy and all institutional policies, also a set of hard copies may be kept at focal point like library
 accompanied by formal notifications for the awareness of all stakeholders to promote transparency,
 facilitate compliance, and strengthen institutional governance.
